A Message from Farmworker Health Network (FHN)



AGRICULTURAL WORKERS AND MENTAL HEALTH

Mental health is an important component of an individual's overall health. During times of crisis, like the current pandemic, it is especially critical to prioritize your mental health and practice self-care. Agricultural workers, however, may have more difficulty identifying, treating, and overcoming mental health concerns due to the multiple challenges they face including language barriers, poor access to health insurance, and high rates of poverty. Poor mental health affects an individual's productivity, their hobbies and motivations, their ability to handle life challenges, and their overall contentment and ability to enjoy life. NCFH has compiled some mental health resources that may be helpful as you navigate the impact of COVID-19 at your health center and continue to treat vulnerable patient populations, including agricultural workers. Always presume that the virus is present. Our understanding of its spread remains limited. Asymptomatic individuals may be unwittingly spreading the virus. In the absence of extensive testing and given our early understanding of the disease, take full precautions as if COVID-19 is present.

Policy Updates



Farmworker Justice Policy Update:

Representative Khanna and Senator Warren recently introduced an Essential Worker Bill of Rights. The Essential Worker Bill of Rights outlines policies aimed to protect essential workers, including farmworkers, for inclusion in the next COVID relief bill. These policies include health and safety protections, premium compensation for essential workers, and universal paid sick and family leave, among others. Farmworker Justice Policy Update

Several states issued guidance through their state agencies regarding COVID-19 and agricultural workers. Oregon OSHA issued a temporary rule addressing COVID-19 in employer-provided housing, labor intensive agricultural operations, and agricultural transportation. The rule went into effect on May 11, 2020. Several other states issued COVID-19 guidance for agricultural employers. Consult your state's department of agriculture, department of health, or department of labor for any published guidance.
